Centre Approval

The centre approval fee only applies to new centres who are not already approved for OAL qualifications. The cost covers the approval process and all the review and checking of policies and procedures, staff qualifications and CVs etc. to ensure your centre meets all the quality and regulatory requirements we need to have in place. The cost also covers an initial approval visit and the approval for up to three qualifications if these are applied for at the time of centre approval.

Annual Approval

The annual approval cost covers one EQA visit per year to enable your centre to apply for certification for each of the qualifications you are approved for. It also provides you with on-going access to all our resources on the on-line portal if your centre and its staff are demonstrating you meet all the requirements in the Centre Contract, we send out for you to sign each year. **Signing the centre contract is your centre confirming that you are still operating in the same way as when you applied for centre approval and that the quality and compliance requirements for continuing to offer OAL qualifications are in place.**

Qualification Design and Development

We can collaborate with you to design new qualifications or adapt and re-design them to meet your needs and employer requirements. If you would like to engage with this service, there are a number of stages we have to work through with you to ensure the qualification is designed and structured in the right way and will meet Ofqual regulatory requirements.

Our fees and process for this service are detailed below.

Activity	Fee
Initial meeting to discuss and scope out development requirements and agree all actions/stages and plan employer and centre involvement. This will be a minimum of 1 - 2 hours and can be conducted face to face but also through MS Teams.	Free one hour session to discuss viability of request and further information required if completed by Teams/Zoom. If a face-to-face meeting is required/ requested, then this will be charged at £360 to cover travel and other expenses.

Administration Fees

Registrations

All learners must be registered when they start their OAL qualification as a minimum this must be within two months of them starting their programme with you. The qualification evidence that is provided for OAL to be able to effectively quality assure, and award certificates cannot pre-date the registration date.

Cancellations and Withdrawals

Cancellations are when learners or whole batches of learners are removed from a qualification, not to be reinstated. If you cancel your learners within five working days of registering them, the registration fee will be refunded. After 5 working days, you will not have the registration fee refunded as we will have incurred the administration costs associated with the registration. A cancellation fee will be incurred of £30 per learner for an individual learner and £35 per learner for a batch of learners.

Withdrawals are when learners or whole batches of learners are temporarily removed from a qualification. No refund or fee applies, and these learners are withdrawn if this is completed on our portal in a timely manner and the reason for withdrawal provided.

Certification Fees

Replacement certificates and proof of qualification fees apply. Please see the table below for our charges for this service. If a replacement certificate needs to be issued for reasons such as a learner's name being registered incorrectly, or if a learner loses their certificate, then the fee will apply.

We can provide proof of qualification for a small charge without reissuing a certificate. Please ensure you let customer service know this and they will support you with this process.

Appeals and Remarking of Knowledge Tests

A fee is charged for an appeal submission or a request to remark a Knowledge Test. If the appeal or remark outcome is not in favour of the appellant, we will invoice for this activity. (This fee will be charged to the provider not to the learner). Please refer to our appeals policy on our website for this process which provides details for appeals at each stage.
